Subject: Comments on the permitting process for the HiTest Silicon Facility

Dear Chair Ashton, Director Snow and Planning Commission Members,

We understand that Pend Oreille County is current reviewing the HiTest Silicon smelter proposal. According to the Pend Oreille County Property Search webpage, the properties owned by HiTest Sand have a County Comprehensive Plan designation of and are zoned Public Lands (PL).¹ Industrial uses, such as a silicon manufacturing plant, are not permitted in the Public Lands (PL) zone.²

To site a silicon manufacturing plant on this land, the comprehensive plan's future land use map will have to be amended and the property rezoned to a comprehensive plan designation and zone that permits manufacturing uses. The comprehensive plan amendment and rezone will need to comply with the processes for these amendments including the county's public participation program and the requirements of the Growth Management Act.<sup>3</sup>
